Whimple Parish Council meetings take place in the evening at 7pm at Whimple Victory Hall.

Whimple Parish Council meetings take place on the first and third Monday of every month. A Planning meeting is held on the first Monday of the month, but may be subject to cancellation if no consultations have been received from East Devon District Council. The Full Council meeting takes place on the third Monday of the month (with the exception of August when the Council does not meet).

If you are unable to attend a meeting you are required to notify the Parish Clerk as soon as possible, to ensure that your apologies are given to the meeting and you are not recorded as being absent.

If you fail to attend any meeting of the Council for six consecutive months from the date of last attendance, you automatically cease to be a Councillor on Whimple Parish Council as per the Local Government Act 1972, unless the Council accepts a reason for the failure to attend before the six month period expires.
